All sales constitute a contract between buyers and seller of each animal sold.

OZARK LLAMA CLASSIC assumes no responsibility, legal or otherwise, in regard to the sale contract.

All llamas in the sale are required (no exceptions) to have a veterinarian signed certificate of health certifying the animal to be free from infection and contagious disease within 30 days of the Sale. Scabies (Ivomec treatment) within 21 days of sale and so noted on the health certificate. All animals must have permanent identification.

All females selling as pregnant must be pregnancy checked for a DVM not more than 30 days before the sale and proof of pregnancy must be turned in to the sale management prior to the sale. All breeding males must be checked and certified by a DVM to have both testicles present.

The consignor agrees to hold OZARK LLAMA CLASSIC harmless from damages in the event that unusual or unforeseen circumstances result in the change of location, change of time or date or cancellation of similar modification of this sale.

Original ILR Certificates must be turned in at check in along with the health papers and additional information that would be helpful for the sale of your animal.
